Optional Judges' Exam

- **'22-26 DP Optional Practical Exams:** offered August 1, 2022 (start of the new '22-23 Accreditation year).
- **All Written (theoretical) Exams** will be offered as online exams only.
- **Level 8, 9 & 10 Practical exams:** will be administered in-person / available at all USAG Congresses held in August and local Test Administrators throughout the year.
In-Person Practical Exams: will require that each individual be linked to the internet with a personal electronic device with which to enter their scores. More specific information will be announced this summer.
