This year we had 76 judges that volunteered at Judges Cup and got their memberships paid.

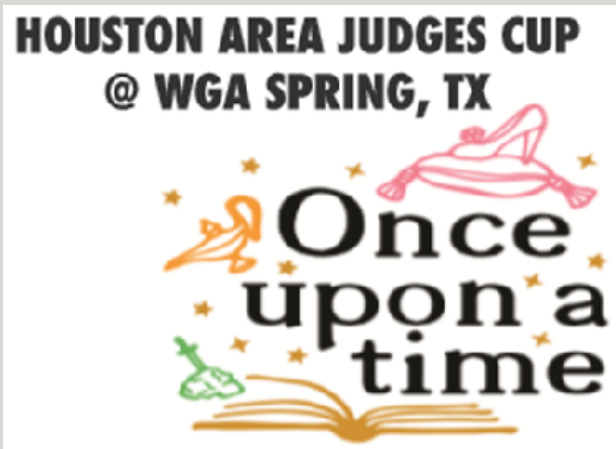

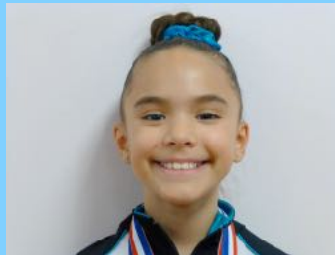

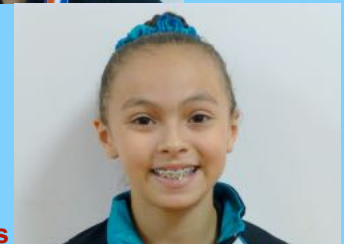

**Area Reports:** Each assigner & board member gave a brief report on their district and/or the ongoing on their position at this time.

#### District 1:

West Texas continues to ebb and flow on the number of judges in our area. We may be very limited on the number of our judges, but they are a very dedicated group and so far committing to all 6 weeks in a row with extended travel included. I have been very fortunate to have such a dedicated team.

#### Districts 2/3:

We have had a wonderful year of gymnastics in the Dallas/Fort Worth Metroplex! We added several meets in the Spring and had record numbers of athletes at our yearly invitationals. Xcel is booming here as well. Many clubs are thriving due to record numbers of Xcel athletes. More kids are staying in the sport as a result. We added several new judges to our ranks and are working to get them comfortable judging. Finally, my judges are some of the hardest working professionals I know. Everyone passed their judging exams with flying color. We also have a couple of new Level 10 judges. I couldn't be happier serving as the District 2/3 Assigner.

#### Districts 4/7:

There are approximately 35 judges in the area. We gained and lost some last year. Many judges are affiliated, especially in the San Antonio area. We are still short judges several weekends despite having a good amount. We encourage all of the judges to participate in Judges Cup even if only for a session or two. Judges need to make sure their information is up to date in GymJas. Everyone seems to like GymJas. The biggest problem is the two step approach that requires judges to both CONFIRM & CREATE their contracts. Several judges still need to provide copies of their memberships showing that SAFE-SPORT has been completed.

#### Districts 5/6:

We survived Harvey! Some gyms and a few judges had damage. With the help of a few gyms & Sally, funds were raised and distributed to those in need. We have 38 judges with ratings on the list. 6 have not turned in updated info & I still have several that don't judge for various reasons. 6 judges moved over the Summer. Pat Ethredge is retiring this year, but she will still be involved in hosting the TX Classic & the Svetlana Invitational.

#### High School Assigning 2016-17 (North Texas):

187 High School assignments were made in the DFW area. High School meets are thriving. At Judges Cup, please sign up your interest in judging the High School meets. There is a list of reminders to share with the High School coaches regarding communication with meet scheduling, cancellations, start times, meals provided etc. . Denise will get these requests in print and available to the High School Meet Directors

## Event Coordinator Report:

We had 3 judges register National Congress through Texas NAWGJ and 18 register for Region 3 Congress in Dallas. We had 22 volunteers for the Region 3 Xcel meet in Galveston. Snail mail reminders have gone out for Judes Cup to the 266 clubs in the state. We are so thankful for the positive representation of the educational events and in filing the volunteer positions.

## Website:

Website renewal proposal was discussed. Our hosting fees have gone up from 14.14/month to \$23.99/month but includes some extras that we are paying for separately. If we sign a 3 year contract, we can get the \$14.99/month price. It will be a long term savings, but more money right now.

Request for reimbursement will be submitted to the Texas NAWGJ Treasurer within 30 days of travel and will require a self-addressed stamped envelope.**

The Green Flag Award will be awarded to a judge who goes above and beyond. This new award will begin at GAT 2019.

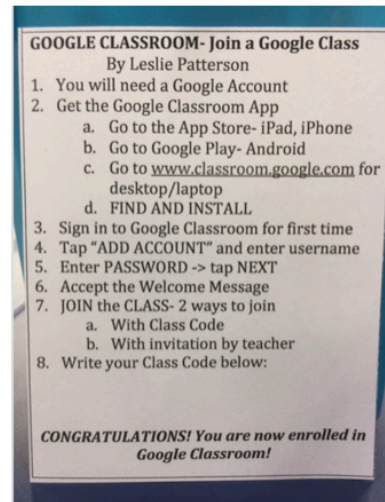
