High School Fee Structure & High School Meet Clarifications:

Becky describes and clarified some confusion on the new high school fee structure. It aligns with what UIL does.

- If a judge is cancelled within 2 weeks of a meet, a fee of 2 hours pay is due to the judge according to the terms of the contract. Extenuating circumstances, such as weather, can wave the payment on a case-by-case basis. Simply reducing the number of judges at the last minute will not waive the fee.
- Schools should provide a school map (even hand drawn) indicating the location of the competition gym to Bonnie. She will compile a list and distribute to the judges. Newer judges are not always familiar with some of the larger campuses and the gym/parking locations.
- We're seeing a resurgence of schools that aren't paying our judges. I think it's reasonable to wait a cycle, or maybe even two cycles (a cycle often is one month for a school district), but if it's been an unreasonable amount of time (>2 cycles), we may consider not assigning judges to future meets until the matter is cleared.
