## **Assigning Collaboration:**

Discussion on judges not getting their meet assignments n a timely manner especially for state and regional meets. Again, it is vital that judges keep their availability up to date at all times.

Meet directors must submit their requests for judges early.

- Judges must submit their availability early.
- District assigners assign together and early to ensure mileage is factored in
- Compulsories: \*State meet assignments with contracts \*District qualifier and championship meet assignments \* Judges assigned to their state meet level and event at least x number of meets
- Optionals: \* Regional meet assignments in November \* State meet assignments with contracts \*
   Invitational meet assignments \* Judges assigned to their state meet level and event at least x number of meets
