## Important: Changes to the U110: U.S. Center for SafeSport Training Expiration Dates

Starting June 1, expiration dates for U110 training will be issued using the following calendar: judges, not working directly with athletes, may take the course with the August 1- May 31 dates.

- **June 1-July 31, 2022:**

Members who complete the U110 from 6/1/22 - 7/31/22, will be issued a U110 expiration of 12/31/22 & will be required to renew their U110 again before 12/21/22 to remain active.

- **August 1, 2022-May 31, 2023:**

Members who complete the U110 from 8/1/22 - 5/31/23 will be issued a U110 expiration of 7/31/23 only having to complete the course once within the season.
