## Over 91 Mile Travel Range Session Fee \& Mileage

(A) All members of the officiating crew will receive the base session fee. Officials will be reimbursed portal to portal (roundtrip travel from official's home address to venue address) one car at state rate, two cars at $75 \%$ of the state rate, or three cars at $60 \%$ of the state rate.
(i) Officials shall be paid based on the state travel reimbursement rate in effect on August 1st of the current school year.
(B) A $\$ 15.00$ riders fee will be paid for contests over the 91-mile range.
(C) Meals will be paid at $\$ 15.00$ during regular season competitions and $\$ 30.00$ during playoffs for travel over 91 miles.
(D) By prior agreement between officials and school authorities, airfare may be substituted for automobile travel fee
