I first heard about the Happy Hour game at a local clinic I helped with in Houston. I thought it sounded like such a fun, interactive way to practice judge.

At this year's Houston Judges Cup some of the new level 9 and level 10 judges were talking about practice judging hours they needed, and I offered to host a Happy Hour.

We started with Level 9 bars, and after that first one we had a group of judges who were interested in playing a round for the rest of the events.



Hosting does take some preparation time, but with all the rules I have to keep straight it really helped me too! We ended up playing 10 routines on each event for level 9 and level 10. It was such a lively way to connect with fellow judges and prepare for optional season!

A little bit about me.....

Gymnastics has been a part of my life since I could walk. As an athlete, I spent four years on the US National Team and earned a gymnastics scholarship to the University of Florida. I received my first judge's rating while still in college and progressed to coaching, overseeing a large girls' program in Tampa, FL.

While coaching girls, I ventured into judging men's gymnastics. In 2013, I earned my FIG International Brevet for Men, and in 2018, I was the first woman to judge Men's NCAA Championships. Throughout the years, I consistently re-tested and maintained my Women's rating, and in 2021, I achieved FIG International Brevets for both Men's and Women's artistic gymnastics.

Currently, I judge all levels in both disciplines. I have many years of teaching and mentoring experience on the men's side, and I am happy to share my experience with the women's program in Texas!

Congratulations to Katie Kuhleman

I've always loved challenges and sarcasm so when I was scrolling social media and saw a virtual adult gymnastics competition called, "Everything Hurts" I thought it was funny and figured why not! I already worked at a gym so I just needed permission from the owner to use the gym to

train and record.

For several weeks I would try to plan to work out with help for spotting and safety since it had been twenty years since I had done many of the skills. The plans kept falling through. With only a couple weeks remaining to submit my videos for the virtual competition I recruited the help of a former gymnast turned collegiate acro and tumbling base to help with vault and bars. We spent at least four hours at the gym on a Sunday afternoon working on relearning and perfecting skills. I recruited another coach and friend to help with floor and beam the following weekend and spent another upwards of six hours at the gym. In my living room at home I learned one of my own gymnasts floor routines that was created by Gelena Verucci and then perfected it at the gym. I never lost my ability to perform a back handspring on floor! The hardest event was bars because I had a terrible injury on a playground in Ukraine in 2004 and never quite recovered mentally, but I'm too competitive to have not participated in the All-Around. Something I had only had the opportunity to do three other times in my life.

I had my former gymnast and friend video my routines those two weekends and practiced until I was satisfied with the result and sent them to the organizers for the virtual competition *Everything Hurts Meet*. One very long week later I was notified of the results. I won 1st place all around with scores:

Vault 9.325, Bars 9.3, Beam 9.3, Floor 9.45, All Around 37.375 My husband was so proud of me that he made me a banner!



A little bit about me.....

I began taking gymnastics at the age of four in Middleburg Heights, OH at the YMCA. I quickly fell in love with the sport, but taking classes didn't last very long. I'd beg my parents to let me do gymnastics and I'd get to do gymnastics off and on through the Strongsville City Rec Center throughout elementary school. In middle school I was on the spirit team and the varsity cheerleading coaches knew who I was because of my older sister. I ended up getting to take a tumbling class at a private gymnastics gym with the varsity cheerleaders and the gym owner ended up letting me do gymnastics too. I tried out for the gymnastics team in high school and made it. I finally had a chance to compete once I got the skills required for what was probably considered modified Level 8 or 9. I got my floor skills first, followed by beam and vault, and then only competed a very sad bar routine once for a JV meet. I also got to compete all around in two AAU meets in Ohio when I was 18 years old. I actually skipped prom to compete. I ended up cheering in college at Indiana Wesleyan University so I could continue tumbling and was given a scholarship after receiving an invite to attend varsity camp. I've continued to work in the sport both as a coach since high school and a judge after I moved to Texas. I attained my level 10 rating this past year and look forward to years of judging the talented athletes in Texas. While my husband, a fire fighter, and I are busy raising our 4 daughters and both working, there is always a lot of excitement and the days are filled with love and joy.
