## The CARES Act

Coronavirus Aid, Relief, and Economic Security Act

## \$1000 GRANT

Under the CARES  
Act passed on March 27,  
2020, independent  
contractors, gig workers,

and freelancers affected by the coronavirus crisis are eligible  
to receive a government grant of \$1,000.

The SBA sometimes refers to these grants as "advances," but you are not required to repay  
this money to the government.

The application process involves filling out a simple SBA form requesting an Economic Injury  
Disaster Recovery Loan (EIDL), which provides for the advance even if the loan is not granted.

We are in the process of exploring alternative dates for events that have been impacted by the Coronavirus and the postponement of the Tokyo Games. Specifically, we are working with the USOPC and the St. Louis Sports Commission to reschedule the Olympic Trials, once the new dates for the Olympic Games are set. Barring any scheduling conflicts, we are planning to hold Olympic Trials in St. Louis in 2021.

We are also exploring rescheduling 2020 events to late summer or fall, but only if it is safe to hold events in light of the global pandemic and our athletes' ability to train appropriately beforehand. Specifically, we are exploring the possibility of rescheduling the 2020 GK U.S. Classic, 2020 U.S. Championships, 2020 USA Gym Championships and 2020 National Congress and Trade Show.

As you can imagine, working through the rescheduling of these events, and the details of each, is challenging and complex, so we truly appreciate your patience and understanding as we navigate through this.
